TOURNAMENT RULES

I/WE HEREBY AGREE TO ABIDE ALL THE RULES OF THE TOURNAMENT

MODIFIED SYSTEM 36 is a Same-Day Handicapping System that allows golfers who don't have official handicap indexes to play in tournaments that require the use of net scores.

System 36 assigns a point value to golfer's score (pars, bogeys, etc.) at the end of the round, add up those points values and subtract from 36. That becomes the golfer's handicap for the round just completed.

- A double bogey or worse is worth 0 points
- A bogey is worth 1 point
- Pars and everything better than par-birdie are 2 points each

MODIFICATION: To speed up play, a maximum score of double par plus two strokes will be automatically applied to a potential score of triple bogey or when a player opts to pick up his ball.

<u>LATE PLAYERS:</u> Players who are late based on the Shotgun tee of 8:00 AM are still eligible to play. However, they will get an automatic score of DOUBLE-PAR in each hole that they missed. Upon their arrival, they will start on the next hole where their co-flight members are located (if their co-flight members are in the middle of the fairway, then the late players will start on the next hole.)
